She was appointed to the Board of MCB Ltd in 2004 and was a Director thereof until March 2014, after which she joined the Board of MCB Group Ltd following the restructuring of the Group. She is also the Chairperson of Compagnie des Villages de Vacances de L'Isle de France Limitée (Covifra) and is a Board member of several companies within the MCB Group.
